## **Corporate Profile**

To be listed on the Philippine Stock Exchange, Inc., Del Monte Philippines, Inc. is a leading producer, distributor and marketer of premium quality, healthy food and beverage products. It has been in operation in the Philippines for over 90 years and is the market leader in the packaged pineapple, canned mixed fruit, canned and carton ready-to-drink juices, tomato sauce and spaghetti sauce categories.

DMPI has the rights to the *Del Monte* trademark for the Philippines for processed products. It also sells products under the well-known *S&W*, *Contadina* and *Today's* brands. More than half of DMPI's sales are in the Philippines and the balance for exports.

DMPI operates a fully-integrated pineapple operation with its 26,000-hectare pineapple plantation in Bukidnon, Philippines, and a factory that is about an hour's drive away from the plantation. It also operates a beverage bottling plant in Cabuyao, Laguna.

Post-IPO, it is expected to be 80%-owned by Del Monte Pacific Limited ([www.delmontepacific.com](http://www.delmontepacific.com)), a company listed on the Singapore Exchange and the Philippine Stock Exchange.
